- 1. PROPOSED BY JOINT RESOLUTION OF THE GENERAL ASSEMBLY TO AMEND SECTION 6 OF ARTICLE IV AND TO REPEAL SECTIONS 19 AND 22 OF ARTICLE IV OF THE CONSTITUTION OF THE STATE OF OHIO**
 - 1. Increase the maximum age for elected or appointed judicial office from 70 to 75.**
 - 2. Eliminate the General Assembly's authority to establish court of conciliation.**
 - 3. Eliminate the Governor's authority to appoint members to a Supreme Court Commission.**

- 2. REFERENDUM, SENATE BILL 5**

Amended Substitute Senate Bill 5 is a new law relative to government union contracts and other government employment contracts and policies.

- 3. PROPOSED CONSTITUTIONAL AMENDMENT TO ADOPT SECTION 21 OF ARTICLE I OF THE CONSTITUTION OF THE STATE OF OHIO**
 - 1. In Ohio, no law or rule shall compel, directly or indirectly, any person, employer, or health care provider to participate in a health care system.**
 - 2. In Ohio, no law or rule shall prohibit the purchase or sale of health care or health insurance.**
 - 3. In Ohio, no law or rule shall impose a penalty or fine for the sale or purchase of health care or health insurance.**
